

Minutes of Review Meeting of OUIDF-Funded Projects held on 27.10.2017 at 4.00 pm in the Conference Hall of H&UD Department, Secretariat.

Commissioner-cum-Secretary, H&UD Deptt. presided over the Meeting. After a detailed review the following decisions were taken.

- I. **Modern Abattoir at Gadakana**
  - i. PDA to suggest way forward for appointment of O&M Operator.
  - ii. Industry players across the country may be reached out to formulate a workable model and have the plant operated at all cost.
- II. **STPD Decentralized waste processing facility at TTS Gadakana, BMC.**
  - i. RFP for appointment of agency for installation & operation of compost plant for BMC will be floated by 28.10.2017.
- III. **Reclamation of water bodies in Berhampur**
  - i. PDA to visit Berhampur next week for kick off meeting. Work plan for implementation of the Project to be finalised with due consultation with Commissioner.
- IV. **Reclamation of water bodies in Titilagarh**
  - i. Titilagarh Municipality to update the cost estimates for the Project and submit the DPR for technical sanction in 15 days.
- V. **Reclamation of 100 water bodies across various ULBs in Odisha**
  - i. Selection of Consultant for preparation of DPR and PMC for Reclamation of water bodies will be of 4 packages – RFP to be floated by 03.11.17
  - ii. OUIDF will collect information <sup>on</sup> list of Consultant firms who had bid for Sabarmati river front development project. & invite them to participate
- VI. **Meat Market at Ghatikla and Unit IV**
  - i. Completion of Project scheduled for Ghatikia is November 2017 and Jan 2018 for Unit IV.
  - ii. BMC to initiate process for shop allotment in November 2017.
- VII. **Alternative Source of funds for OUIDF**
  - i. PDA to make quick progress in engaging with New Development Bank for securing a Line of Credit.
- VIII. **OUIDF Sanctioned projects in Sambalpur**
  - i. Discussion with Collector of Sambalpur to be held on 28.10.2017 regarding implementation of OUIDF sanctioned projects for Sambalpur.
  - ii. Shop allotment for Fish Market to be expedited by SMC.

- IX. **Energy Efficient Street Lighting Project for 5 Municipal Corporations**
- i. Concessionaire to mobilise resources for survey work by 6<sup>th</sup> Nov'17
  - ii. OUIDF to check and confirm the agency responsible for quality check of installations.
  - iii. Special Secretary to speak to ADM, Rourkela about concerns related to signing of Loan agreement.
- X. **BDA Housing Projects**
- i. BDA to sort out the issue w.r.t GST raised by the contractors and initiate signing of Agreement for the projects scheduled for next week.
- XI. **Toilet on Wheels**
