PREFACE

It gives me immense pleasure to note that Odisha Urban Infrastructure Development Fund (OUIDF) under Housing and Urban Development Department is bringing out its 6th Annual Report for the Year 2017-18.

Sustainable & inclusive urban infrastructure is a prerequisite to achieve broad based and inclusive growth in a sustainable manner for all sections of the Society. The rapid growth of Urbanisation has posed huge challenges for Infrastructure Development & delivery of civic services in various sectors like Sewerage, Drainage, Water Supply, Solid Waste Management, Storm Water Management, Slum Development and Rehabilitation with Affordable Housing, Energy Efficient Public Street Lighting, etc. Odisha Urban Infrastructure Development Fund was set up in the year-2012 with the objective of meeting these challenges effectively by providing Financial & Project Development Support to the Urban Local Bodies & parastatal agencies of the State.

To implement the above objectives, OUIDF had availed Ist Line of Credit from KfW Development Bank of Germany amounting to 50 Million Euros (INR 420 crore) in 2012 to finance eco-friendly Infrastructure Projects and has already invested Rs. 404 crore (Euro 48 Million) by the end of March' 2018. In the meantime, 2nd Line of Credit amounting to Euro 55 Million from KfW, Germany has been firmed up for investment during next 6 years (2018-2023) for various Urban Infrastructure Projects.

The Ist Line of Credit of KfW was invested in sectors contributing to positive environmental impact like Sewerage System, Water Supply, Solid Waste Management, Reclamation & Rejuvenation of Water Bodies, Street Lighting etc. Major Projects in these sectors include Water Supply to Greater Berhampur and Gopalpur NAC, Bulk Water Supply Project under PPP mode at Bhubaneswar, Sewerage System Projects at Rourkela and Sambalpur, Reclamation of Water Bodies at Bhubaneswar, Sambalpur & Berhampur, Integrated Solid Waste Management at Berhampur & Street Lighting Projects in 5 Municipal Corporations.

I am hopeful that the Odisha Urban Infrastructure Development Fund (OUIDF) will further step up its efforts to promote Urban Infrastructure Development in more & more ULBs to achieve the objectives of OUIDF to ensure sustainable urban infrastructure development.

Background

The Union Government in the recent past has substantially stepped up its investment in urban infrastructure sectors like housing, sanitation and solid waste management, water supply, sewerage etc. However, rising level of income coupled with economic prosperity is likely to drive greater demand for infrastructure investment in India over the next 25 years. According to an official estimate, around US\$ 4.5 trillion worth of investment would be required in India till 2040 to develop quality infrastructure that will contribute to sustainable economic growth & improved community well being. Considering the indigenous resource availability, it is further estimated that there would be an infrastructure investment gap of around US\$ 526 billion by the end of 2040. Several infrastructure development programmes announced by the Central Government, to name a few (like AMRUT / Swachha Bharat Mission & Housing for All, Smart City Mission etc.) are already on the anvil with a well planned investment module & a sound strategy to ensure effective time bound implementation of these programmes across the country without time/cost overrun.

The initiatives undertaken by the Union Government coupled with its well formulated infrastructure investment planning provides an ample evidence of its commitment for sustainable development of infrastructure with the active involvement of the State. Being in a Federal Structure & in order to derive the benefits from the programmes already initiated by the Central Government, the State Government has formulated its policy on Infrastructure Development in line with the above plans & priorities of the Government at the Centre to derive synergy effect. Sustainable infrastructure development & planning, is an inescapable necessity for the State which is already in a growth trajectory aspiring for a superfast economic progress. The continuous surge in the economic activities in the State is the compelling reason for continuous & increased budgetary allocation for infrastructure planning & development which has witnessed an almost tenfold growth during the last decade.

The Government in the State has also placed emphasis on schemes like Smart City Mission, AMRUT, Swachh Bharat Mission AWAS, Hridaya etc. The Housing & Urban Development Department is the nodal Department of Government of Odisha for ensuring proper and planned growth of cities and towns with adequate infrastructure, amenities and services provided to the citizens through the Urban Local Bodies and various parastatal agencies. The H&UD Department has been taking concrete measures for efficient management & delivery of civic services like provision of affordable housing, safe drinking water, sanitation including solid waste management, storm water drainage, sewerage, roads, public transport, energy efficient street lighting and creation of livelihood opportunities by accelerating economic growth in urban locations, The Department takes the initiative for policy formulation as well as the required leadership to channelize the resources for its productive deployment in a prioritized manner.

Odisha's economy have undergone a structural change during the past decade. It continues with a steady growth having impressive GSDP of 7.14% in 2017-18. Human Development and Poverty Reduction are key indicators of inclusive growth and Odisha has a distinction of achieving highest poverty reduction of 24.6 percentage points from 57.02% to 32.6% between 2004-05 and 2011-12.

I.I. Urban Infrastructure Development: A need of the hour

I. With the increasing share of Urban areas vis-à-vis population, urban management poses biggest challenge towards developing quality infrastructure that can sufficiently respond to mark demand of basic services and economic activities. An adequate and efficient infrastructure plays a key role in the growth of an economy and facilitates lives of the people at large. The State Government continues its unstinted efforts to improve spread and quality of social infrastructure like Water Supply, Sanitation, Sewerage, Solid Waste Management, Climate Adoption Measures, Slum Rehabilitation through Affordable Housing, Storm Water Management and other Allied Eco-Friendly Activities for a better quality of life through several programs and projects.

Urban Infrastructure, a key for development, is solely dependent on striking right balance of urban development alongside the infrastructure. The United Nations Sustainable Development Goals-II (SDG) states: "Make Cities Inclusive, Safe, Resilient and Sustainable" embarking on a fast Rural to Urban transmission with achievement of goal in Urban Infrastructure and its challenges.

While nearly 31% of India's current population lives in urban areas according to Census 2011, Odisha continues to be among least urbanized States with an urban population of about 17%. However, the pace of urbanization in Odisha continues to be intensified due to rapid industrialization and good economic performance, which has led to impressive growth in several fields as reflected below:

- b. Urban population grew a 26.8% during 2001-2011 which is double the National Growth vis-à-vis Rural Population growth of 11.7% during the same period.
- c. The number of towns have increased from 138 in 2001 to 223 in 2011 (largely due to increase in census towns from 31 to 116, even though Statutory Towns remained at 114).
- d. Budgetary outlay of Housing & Urban Development Deptt. (H&UDD) has increased substantially during the last decade (around 25 times) in the year 2017-18 (BE Rs. 2439 Cr.) as compared to 2005-06 (BE Rs 101 Cr.).
- e. However, "Municipal Finances" are weak. Capital Investments continue to rely on Government of Odisha (GoO)'s budgetary outlays and grants. Debt Financing is limited to State supported Projects and constrained by inadequate capacity to develop Bankable Projects.
- f. Odisha has 114 Urban Local Bodies across 3 categories, namely 5 Municipal Corporations, 47 Municipalities and 62 Notified Area Councils. The legal framework for the urban sector is provided by the Odisha Municipal Corporations Act, 2003, applies to Municipal Corporations and the Odisha Municipal Act, 1950, is for the Municipalities and the NACs. The Urban Local Bodies (ULBs) need to play a major role in mobilizing resources for infrastructure development in cities. The weak financial base of the ULBs being their major constraint, it limits their spending on infrastructure services. The

- ULBs therefore need to exploit potential, cost effective & non-conventional means of resources mobilization to achieve their social welfare objective. As a result, this will boost inclusive and overall development of cities/ towns into livable, economically vibrant, sustainable and efficient entities with provision of adequate and durable public infrastructure and amenities in a convergent manner.
- g. Even though the Municipal legal frame work allows flexibility to access loans at the ULB level, Debt Financing for the Urban Projects is limited to multi-lateral and bilateral financing to derive the benefits as presented below.

1.2. Envisaged Benefits

- Integrated approach to Urban Development with access to fixed, low interest long-term funds and technical assistance to build expertise in implementing "Bankable Projects".
- Leveraging Government interventions and available subsidies under various Programmes thereby contributing to highest economy of scale in operations of feasible Projects.
- ▶ Introducing ULBs to rigour of Debt Servicing discipline leading to gradual reduction on Budgetary Dependence.
- ▶ Procurement adopting International Guidelines of Multilateral Agencies.
- ► Greater scope for private sector participation in asset creation and service delivery.
- ► Capacity Building of ULBs through professional support out of Technical Assistance Grant.

About Odisha Urban Infrastructure Development Fund (OUIDF)

2.1. Vision & Mission

Vision

The Vision of OUIDF is to be a sustainable financial intermediary that enhances the flow of private capital to urban sector in Odisha and facilitate Urban Local Bodies to become capable and sustainable organisations, sensitive to stakeholders in providing the highest quality of Urban Services.

Mission

The Mission of OUIDF is to contribute to improvement in urban quality of life in Odisha by facilitating efficient Urban Infrastructure Asset Creation and Provision of Urban Service through Innovative & self sustainable Projects.

2.2. Objective

In line with the Policy Guidelines enunciated by the Union Government, Government of Odisha (GoO) has also focused on development of urban infrastructure. This is expected to meet the rising demand for urban amenities keeping in pace with the rapid growth in urban population as well as to successfully manage the huge challenges / opportunities arising out of such rapid urbanisation. Urban Infrastructure Projects such as Slum Rehabilitation through Affordable Housing, Cost Effective Water Supply, Comprehensive Sewerage

Systems, Sanitation, Solid Waste Management, Climate Adoption Measures contribute to improvement of the environment as well as provide a better quality of life for the Urban Poor. The State Government has therefore placed utmost importance on the balanced and planned growth of cities/ towns with adequate infrastructure and basic amenities through Urban Local Bodies and other Agencies.

With this back drop, the Government of Odisha, with assistance from KfW, Germany has set up a Trust, the Odisha Urban Infrastructure Development Fund (OUIDF) for the purpose of Developing and Financing Eco-Friendly Infrastructure Projects undertaken by Urban Local Bodies, Statutory Bodies, Public Sector Undertakings of the State and Private Investors and attracts *inter alia*, investment and professional advice from Institutions for financing Infrastructure Projects.

The primary objective of creating OUIDF is to progressively increase external financing of ULB level capital projects in a sustainable manner, without a "State Government Guarantee." Creation of OUIDF, as part of an over-arching Urban Development Programme, would enable this through;

- a. Catalysing development of well-structured Bankable Projects;
- b. Capacity Building for Project conceptualization, development and implementation; and
- c. Facilitating / Sensitising State and ULB level reforms that can be pre-cursors for further investment flows.

The focus of OUIDF's charter includes the following:

- a. To provide Financial Assistance to the various executing agencies like Urban Local Bodies, Statutory Boards, Public Sector Undertakings and Private Investors in the form of long-term low-cost Debt along with Viability Grant, for setting up sustainable positive environment impact Infrastructure Projects in the State of Odisha.
- b. To provide required hand-holding support to the executing agencies for procurement as per international guidelines adopting a fair and transparent procurement system.
- a. To provide long term debt or take equity position in the Infrastructure Projects sponsored by Private Investors on a commercial basis when the Infrastructure Projects are considered strategically important.
- b. To become financially self-sustainable and to mobilise sources (including private and capital market) to finance Urban Infrastructure Development.
- c. To provide Grant Support to the executing agencies for Project Development, preparation of Detailed Project Report as well as Project Monitoring / Management & Consultancy Services.

2.3. Sector Focus:

Sectors and Projects with positive environment and social impacts:

- Water Supply and Water Supply Improvement Schemes (WSIS);
- ▶ Underground Sewerage Schemes (UGSS);



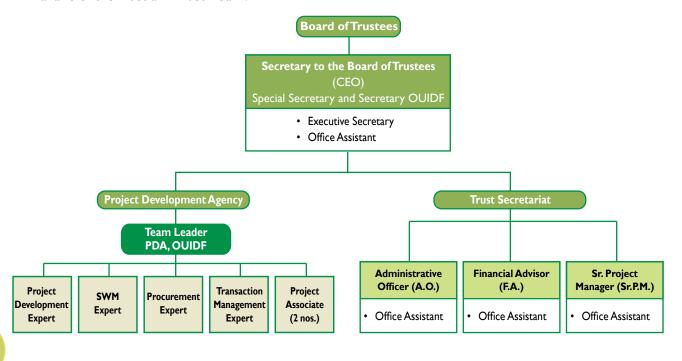
- ► Solid Waste Management (including Landfill Sites, Waste-to-Energy, Segregation, Recycling and Reuse, Larger Compost Yards / Dump Area);
- ► Climate Adaptation Measures (e.g. Storm Water and Flood Drains);
- ▶ Slum Development, Rehabilitation, Provision of Basic Amenities to Informal Settlements.

2.4. Organizational Structure of OUIDF

The OUIDF, has been set up as a Trust (under the Indian Trust Act, 1882) under H&UD Deptt. having a Board of Trustees, which will define the "Funds' Charter and Disbursement Guidelines." The Chairperson and the Members of the Board of Trustees have been nominated by GoO. The Trust came in to existence vide Govt. Notification No. 2709, date: 31.01.2012 and Registered Trust Deed dated: 20.03.2013. The Board of Trustee are as under:

The above Trustees shall be collectively known as "Board of Trustees" who would manage and administer the affairs of the Trust and Trust Board.



Support from Government of Germany through KfW

3.1. KfW Lines of Credit

3.1.1. Ist Line of Credit

- ▶ Agreement was executed on 15th May 2009 between Government of India and Government of Federal Republic of Germany for financial cooperation to provide Euro 50 million as Loan and Euro 2.5 million as Technical Assistance.
- ► Government of India channelised the above Funds through GoO to OUIDF to pass 50% of the Fund (i.e., Euro 25 million) as a Capital Grant to ULBs through Grant Support Fund of OUIDF and the remaining 50% as Loan through the Urban Loan Fund of OUIDF. Technical Assistance Grant was passed on to the Project Development Fund of OUIDF.
- ► Accordingly, GoO & OUIDF executed further two Agreements (Project & Separate Agreements) with KfW and availed the assistance from KfW under the Ist Line of Credit, details of which are given below:

3.1.2. 2nd Line of Credit

A Delegation of KfW Officials had visited Bhubaneswar from 6th to 9th March, 2017 as well as from 31st July to 4th August, 2017 and held discussions with Officials of OUIDF and H&UD Dept. as part of Appraisal Mission on Sustainable Urban Infrastructure Development, Odisha Phase-2. The key points of the discussion, inter alia included deliberations on the Objectives of the funding in 2nd Phase i.e., to strengthen OUIDF as a self-sustaining organisation and an important instrument for ULBs and the Government to finance Municipal Infrastructure and help ULBs in providing quality and sustainable services to their citizens. Financing Agreements were executed between Government of India and KfW on Ist week of December' 2017. Similarly, the Project Agreement and Separate Agreement were signed with Government of Odisha in the presence of the Hon'ble Chief Minister of Odisha on 19th December' 2017 to avail further assistance of Euro 55 million as Loan and Euro 2million as Technical Assistance under the 2nd Line of Credit, details of which are as follows:

The Funds under the 2nd Line of Credit shall be fully sanctioned and disbursed within 6 years after signing of the Loan Agreement i.e. by 2023. Total Cost of Projects to be financed has been estimated at Euro 62.5 mn, with sources as detailed below:

 (b) Equity Contribution by GoO to OUIDF for Loan
 (c) Technical Assistance by KfW to OUIDF Project Development Fund
 (d) Equity Contribution by GoO to OUIDF Project Development Fund

The following Projects which are in Pipeline, are proposed to be undertaken under 2nd Line of Credit of KfW Assistance.

- Solid Waste Management Project in various ULBs
- ► Energy Efficient Street Lighting in Uncovered Streets across all ULBs
- Septage Management in various ULBs
- ► Modern Wet Markets & Abattoirs
- ▶ Development of Water Bodies in Water Scarce ULBs

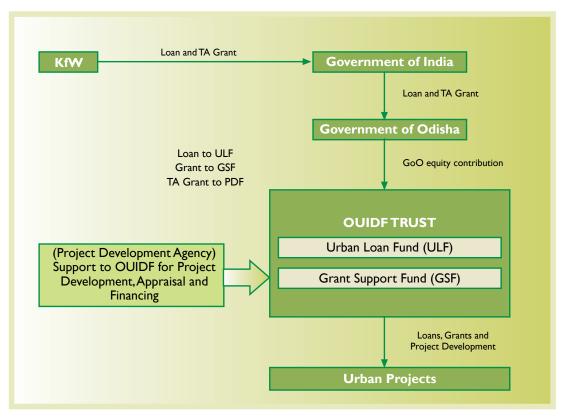
In the 2nd Line of Credit the undernoted Targeted Outcomes are envisaged:

- ► To achieve **Greater Convergence of Schemes** by combining funds from OUIDF with State Grant, SBM, AMRUT, PMAY and develop high quality assets for ULBs across the State.
- Sustainable Financing of water, waste water, solid waste and recycling infrastructure.
- Achieve Better Quality of Life of targeted population by creating infrastructure for clean and healthy environment.
- Access to Improved Recreation and Public Green Spaces for inhabitants.
- ▶ LED Street Lighting Projects to create **Safe Streets** and achieve higher **Energy Savings**.

It is expected that the Projects proposed under 2nd Line of Credit, spread across Odisha, would benefit 6 million urban population of the State.

3.2. Schematic Framework of flow of Funds:

3.3. Institutional Framework of OUIDF

The Institutional Framework of OUIDF consists of an Urban Loan Fund (the "Loan Fund"), a Grant Fund (the "Grant Fund") and Project Development Fund (the "PDF"). A Project Development Agency has been set up to manage the Funds and is responsible for Project identification, development, appraisal, disbursement, follow-up and monitoring of Urban Infrastructure Projects in Odisha. The PDA manages three Funds under the OUIDF Trust as described below:

- i) Urban Loan Fund (ULF): An Urban Loan Fund (ULF) has been set up to provide loans to urban projects on a non-guaranteed mode. KfW under the 1st Line of Credit has provided Euro 25 million (approximately INR 200 crore) for the Urban Loan Fund. GoO has provided Euro 2.5 million as its contribution for this Fund. After successful performance with the 1st Line of Credit within the time-schedule prescribed by KfW, Agreements have been executed in December 2017 in the presence of Hon'ble Chief Minister for availing the 2nd Line of Credit for Euro 27.5 million with GoO contribution of Euro 2.5 million. The 2nd Line of Credit would be utilised by 2023 as per the Agreement executed with KfW.
- **ii) Grant Support Fund (GSF):** The GSF in the 1st Line of Credit availed from KfW amounts to Euro 25 million for which GoO has also provided its contribution of Euro 2.5 million. GSF has been created to

provide Capital Grants to implementing agencies to bridge viability gaps in urban sector projects and to complement debt financing from ULF. The GSF support to various urban sector projects is normally 50% of the total financial assistance of OUIDF and can be given up to 70% in exceptional cases for social Projects requiring major Grant Support. This has helped to promote environment-friendly and socially important Projects like Solid Waste Management, Water Body Reclamation etc. in a sustainable manner.

As per the Agreement executed with KfW under the 2nd Line of Credit, further Grant Support amounting to Euro 27.5 million with a GoO contribution of Euro 2.5 million is envisaged to be infused into the GSF for Viability Grant funding.

- **Project Development Fund (PDF):** The PDF has a corpus of Euro 2.5 million availed from KfW under the 1st Line of Credit as Technical Assistance, with the GoO contributing Euro 0.5 million. The assistance out of PDF is provided for the following purposes:
 - ► Project Identification and Development of Bankable Projects.
 - ► The focus of the PDF is to extend assistance from Concept to Commissioning of Projects viz., the Preparation of City Development Plans, Pre-Feasibility Studies and Detailed Project Reports, Transaction Advisory Support, Project Monitoring and Consultancy during implementation, etc.
 - ► Conducting Workshops and visits for Capacity Building of resource persons of the executing agencies as well as OUIDF.
 - ▶ Empanelment of Consultants for eco-friendly infrastructure projects in various sectors.

The activities funded out of PDF for the 1st Line of Credit include expenses towards:

- ▶ Project Development Agency appointed for management of the Funds.
- ▶ Preparation of DPRs for projects such as Solid Waste Management, Reclamation of Water Bodies etc.
- ► Appointment of Independent and Authority Engineers and Project Monitoring / Management Consultancy for ongoing Projects for the purpose of monitoring, supervision and quality control.
- ► Transaction Advisory Support for Energy Efficient LED Street Lighting Projects in Green Field Stretches.
- ► Capacity Building Workshops conducted on Contracts Management for the resource persons of ULBs and other Parastatal Agencies.
- ► Sensitisation of ULBs to various reforms.
- Assistance upto Euro One Million to Bhubaneswar Development Authority towards Project Development and Capacity Building component for preparation of Green Urban Development Projects under "Indo-German Smart Cities Partnership" in Bhubaneswar Municipal Corporation.

Considering the useful deployment of the Technical Assistance provided in shape of PDF, KfW was pleased to provide further Technical Assistance of Euro 2 million with GoO contribution of Euro 0.5 million under the 2nd Line of Credit. This will help to further propagate the Project Development Activities in the near future.

New Projects - Approval

The details of the Projects sanctioned by the Board of Trustees of OUIDF during the Financial Year 2017-18 are as follows:

5.1. Reclamation and Peripheral Development of 4 Water Bodies at Hinjilicut

Water Bodies are useful domestic sources for people residing in water scarce areas. One of the very important roles played by any Water Body is recharging of ground water. The Water Bodies trap and store rainwater and other surface flows from streams etc. and recharge the ground water to a very considerable extent. Water Bodies also play a very vital role in maintaining the ecological balance. Deterioration of Water Bodies cause ecological imbalance as well as health hazards.

Hinjlicut NAC has about 7 Water Bodies covering an area of approximately 57 acres with individual area of Water Bodies ranging between 3 acres and 26 acres out of which 4 Water Bodies were proposed to be taken up on priority for reclamation based on stakeholder needs, with an objective to conserve and manage them on sustainable basis; restore and develop the lake periphery for better eco-system, aesthetic, environmental and tourist purpose. The 4 Water Bodies are:

- i. Hinjli Deula Bandha
- ii. Bebarta Bandha
- iii. Jogi Bandha
- iv. Nuagada Deula Bandha

The core reclamation components proposed for these Water Bodies include dewatering, deweeding, desilting and embankment construction. Peripheral components include pathway with hand railing along the periphery of the tanks, fencing, light posts, installation of benches and garbage bins, construction of new bathing ghats and renovation of existing bathing ghats. Additionally, Community Toilets along with bathing facilities are also proposed along the banks of each of the Water Body.

The total Project Cost is Rs. 5.40 crore and OUIDF shall provide Loan & Grant of Rs. 2.43 crore each in favour of Hinjilicut Municipality as sanctioned by its Board of Trustees in its 11th Meeting held on 20.09.2017

KfW has also accorded its Approval for funding the above Project

5.2. Reclamation and Peripheral Development of 2 Water Bodies at Titilagarh

Titlagarh Municipality has proposed the project of conservation of the following two Water Bodies within the Municipal Limits viz.

- i. Deobandha Water Body
- ii. Maharaja Sagar Water Body

with an objective to conserve and manage them on sustainable basis; restore and develop the lake periphery for better eco-system, aesthetic, environmental and tourist purpose.

Deobandha and Maharaja Sagar Water Bodies are two large and most important Water Bodies in Titlagarh Municipality approx. water spread area of 19 and 17 acres respectively. Area adjoining Deobandha has been declared a tourist place and Maharaja Sagar is situated in the heart of the city. Titlagarh is water scarce area and the Water Bodies are in a deteriorated condition in terms of aesthetics, physical condition, surrounding environment, and most important of all, the quality of water. People of the city depend on these Water Bodies for their day to day needs.

The core reclamation components proposed for these Water Bodies include dewatering, deweeding, desilting and embankment construction. Peripheral components include pathway with hand railing along the periphery of the tanks, fencing, light posts, installation of benches and garbage bins, construction of new bathing ghats and renovation of existing bathing ghats. Additionally, Community Toilets along with bathing facilities are also proposed along the banks of each of the Water Body.

The total Project Cost is Rs. 5.41 crore and OUIDF shall provide Loan & Grant of Rs. 2.43 crore each in favour of Titilagarh Municipality as sanctioned by its Board of Trustees in its 11th Meeting held on 20.09.2017

KfW has also accorded its Approval for funding the above Project

5.3. Pilot Project on Toilet on Wheels at Bhubaneswar

In urban Odisha, around 40% of households do not have access to latrine, 11% households share latrines with others. The 2011 Census revealed that 49.6% of the households do not have any kind of bathing facility and about 8.5 lakh people living in slums defecate in open. Of the total 81.44 lakh rural households in the state, only 14.1% have latrines, including 8.6% having water-closet latrines, 3.4% pit latrines and the rest other types. However, the State Integrated Management and Information System (IMIS) data reveals that 54% rural households have access to toilets till 2014.

The "Toilet on Wheels" concept has been borrowed from "Shower on Wheels Model of Lava Mae", which started operations in San Francisco, United States of America. Founded by Doniece Sandoval in 2013, Lava Mae began by converting public transportation buses into showers and toilets on wheels to deliver hygiene and rekindle dignity for homeless people in San Francisco.

In Bhubaneswar, following the model of the Toilet of Pune, it was decided to implement the project in collaboration with Bhubaneswar Municipal Corporation (BMC). Five buses are envisaged to be provided by BMC and refurbished into Mobile Toilet Units in the Pilot phase of the project. In the pilot phase of the Project, 5 locations in three localities viz Old Town – Heritage Area, Master Canteen Bus Stand and Baramunda Bus Stand have been identified to station these Mobile Toilet Units keeping in mind the volume of floating population in these areas, mostly frequented by tourists and daily commuters travelling in and out of the city.

The Project is to be implemented on DBOT mode, wherein the responsibility of Operations would be fixed upon the Private Enterprise.

A fixed user charge of Rs. 5 per person per use is to be charged by the Operator for the initial 3 years of Operation.

The total Project Cost is Rs. 56.20 lakh and OUIDF shall provide Loan & Grant of Rs. 25.29 lakh each in favour of BMC as sanctioned by its Board of Trustees in its 11th Meeting held on 20.09.2017

KfW has also accorded its Approval for funding the above Project

5.4. 5 TPD Compost Plant at TTS, Gadakana, Bhubaneswar

The Solid Waste (Management and Handling) Rules, 2016 issued by the Ministry of Environment and Forest, Government of India (MoEF) under the Environment (Protection) Act, 1986 has imposed a duty on each Urban Local Body in India to undertake a collection, transportation, processing and scientific disposal of Municipal Solid Waste (MSW) generated within its jurisdiction. The SWM Rules 2016 also lays emphasis on decentralized processing facilities for localized management of waste.

BMC intends to undertake a Pilot Project at Temporary Transfer Station site at Gadakana. After successful implementation of the Pilot Project, it will be replicated in other sites in Bhubaneswar and other Urban Local Bodies (ULBs) in Odisha.

Decentralised Composting Schemes can be seen as promising management and treatment options for urban areas as they:

- enhance environmental awareness in a community,
- ▶ are more flexible in operation and management thus adapting rapidly to changes in user needs,
- are close to the residents allowing close quality surveillance of the service and product,
- ► reduce waste management cost for the Municipality as organic waste is diverted from the Municipal Waste Stream thus reducing transportation and disposal costs,
- reduce the cost incurred for the collection, transportation, and disposal of waste by the ULBs.
- do not require Clearances from Environment Authorities for a Compost Plant with a capacity of 5 TPD or less.

ANNUAL REPORT 2017-18

At present, 3 Private Agencies have been engaged by BMC for door to door collection of waste and also from commercial establishments and road side bins. These Agencies also transfer the waste to the Temporary Transfer Station (TTS) at Gadakana, Bhubaneswar.

Under this Pilot Project, it is proposed to set up a 5 TPD Decentralised Compost Plant at TTS. Land area of ~750 (15 m X 50 m) Sq. M has been earmarked for this purpose. BMC will construct a covered shed with toilet facilities and provide power connection for the compost plant. Separate access will be provided to the shed. Operator will be selected for installation of compost equipment and operation of the facility for 5 years. BMC will also supply biodegradable waste of ~ 5 TPD collected from the bulk waste generators in 2-3 Km radius of the site.

The facility will be operated by the Successful Bidder who would also be responsible for Operation & Maintenance of the Plant in addition to setting up of the Plant. The Successful Bidder would be entitled for a Tipping Fees during the Operations of the Plant. BMC may also collect a SWM User Charges from Residents and Commercial Establishments in Bhubaneswar.

The total Project Cost is Rs. 1.52 crore and OUIDF shall provide Loan & Grant of Rs. 68.40 lakh each in favour of BMC as sanctioned by its Board of Trustees in its 11th Meeting held on 20.09.2017.

KfW has also accorded its Approval for funding the above Project.

Project Development & Capacity Building Initiatives

During the financial year 2017-18 the focus of OUIDF included the following:

- ► To broad base its activities across the State, covering all Urban Local Bodies by promoting Projects conforming to the plans and priorities of the Union as well as the State Govt., such as Decentralised Solid Waste Management Projects, Retro-fitting and Greenfield Energy Efficient Public Street Lighting, Reclamation and Restoration of Water Bodies etc.
- ▶ OUIDF has extended hand holding support to the ULBs for Project Development, Bid Process Management as well as for effective implementation of the Projects. Accordingly, it has appointed Consultants as well as Transaction Advisors for preparation of Detailed Project Reports, Bid Process Management and to extend Project Management / Consultancy Support.

The key achievements of OUIDF in this regard during FY 2017-18 are given below:

7.1. Assistance for DPR Preparation, Bid Process Management & Project Monitoring

7.1.1. Energy Efficient Street Lighting Project (Green Field) on PPP basis

The Project envisages to cover an estimated 1268 km of Greenfield Stretches in 113 ULBs in Odisha divided into 5 Geographical Clusters (excluding Bhubaneswar Municipal Corporation) for an estimated Project cost of Rs. 227.30 crore in PPP mode. M/s Deloitte Touché Tohmatsu India LLP has been appointed as the Transaction Advisor for the Project. The Project would be financed upto 90% by the Govt. (10% - ULB, 50% - Govt. of Odisha & 30% - OUIDF Loan and Grant) and the balance 10% would be contributed by the Concessionaires to be selected for such purpose after approval of the Empowered Committee on Infrastructure of the Govt. of Odisha. M/s Deloitte would be paid a fee of Rs. 99.99 lakh (excluding GST) out of the Project Development Fund of OUIDF.

7.1.2. Reclamation of Water Bodies across the ULBs

With the initiative taken by H&UD Dept., OUIDF was entrusted with the responsibility of undertaking the preparation of DPRs and to extend Project Monitoring Support for around 150 Water Bodies in various ULBs for the purpose of the reclamation and renovation. Accordingly, the following Consultants were selected for the above purpose dividing the ULBs into 4 Clusters:

- ► M/s Multi Mantech International Pvt. Ltd., Ahmedabad, Gujarat (Fees @ 3.59% for Cluster I and @ 3.29% of TPC for Cluster 3, excluding GST)
- ▶ M/s Planning Solutions, Vadodara, Gujarat (Fees @ 2.90% of TPC for Cluster 2, excluding GST)
- ► M/s Wapcos Ltd., New Delhi (Fees @ 3.60% of TPC for Cluster 4, excluding GST)

43 ULBs evinced interest for preparation of DPR for the above purpose. As many as 161 Water Bodies were found eligible conforming to the Guidelines prescribed by H&UD Dept. for selection of Water Bodies. M/s Wapcos Ltd. was also appointed as the Proof-checking Consultant of the DPRs for these 161 Water Bodies. Accordingly, efforts are in progress to move forward for preparation of DPR for the Water Bodies which would be considered for financial assistance by OUIDF after obtaining Technical Sanction of the estimates and Administrative Approval of the Project from the Competent Authority.

7.2. Project Monitoring Support

7.2.1. Energy Efficient Street Lighting Project (Retro-fitting) in 5 Municipal Corporations on PPP basis

M/s Pricewaterhouse Coopers Pvt. Ltd. have been appointed as Independent Engineer for the above Project being implemented in the 5 Municipal Corporations at Bhubaneswar, Cuttack, Berhampur, Sambalpur and Rourkela for a Total Project Cost of Rs. 30.08 crore. M/s PwC would be paid a fee of Rs. 67 lakh (excluding GST) out of the Project Development Fund of OUIDF.

7.2.2. Integrated Municipal Solid Waste Management Project, Berhampur

M/s InfraEn (India) Pvt. Ltd. was appointed as Independent Engineer for the 150 TPD MSW Project at Mahuda, Berhampur undertaken by Berhampur Municipal Corporation involving a Project Cost of Rs. 44.44 crore and with financial assistance of OUIDF amounting to Rs. 40 crore. The Independent Engineer would be paid a fee of Rs. 1.25 crore (excluding GST) out of the Project Development Fund of OUIDF.

7.2.3. Water Bodies Reclamation at Berhampur

M/s Wapcos Ltd. was appointed as Construction Supervision Consultant for the reclamation and renovation activities for the Ramalingeshwar and Haradakhandi Tanks involving a Project Cost of Rs. 9.03 crore. M/s Wapcos would be paid a fee of Rs. 38 lakh (excluding GST) out of the Project Development Fund of OUIDF.

7.2.4. Other Project Monitoring Activities

OUIDF improved its monitoring of the Projects by series of interventions viz. –

- ► Kick off Meeting before start of Project by finalising the work plan with intermittent milestones.
- ► Regular monitoring of Projects through WhatsApp Groups, Field Visits and Review Meetings with ULBs.
- ► Flagging critical issues and bottlenecks hampering progress of Projects.
- Follow up on billing and payments to contractors and reducing the timeline for payment cycle.
- Deputing staff to Bhubaneswar Municipal Corporation for monitoring OUIDF Projects under BMC exclusively and providing an Accountant to Sambalpur Municipal Corporation to expedite billing process.
- ► Monthly Review of the Project progress at the level of Commissioner-cum-Secretary and Secretary, OUIDF & Special Secretary, H&UD Dept.
- ▶ Bulk Water Supply Project on PPP mode for IIT Bhubaneswar, NISER and Infocity etc.— Followed up with DEA for release of GOI contribution of VGF. This helped in release of VGF from GoI & GoO amounting to Rs. 50 crore for the Project with an estimated Total Project Cost of Rs. 187.71 crore
- ▶ Effluent Treatment Plant for Fish Markets at Sambalpur Assisted SMC in tendering, evaluation and award of contract for ETP of Fish Markets at 2 locations in Sambalpur
- ▶ Modern Abattoir at Gadakana, Bhubaneswar Assistance to BMC in selection of Operator for running the facility

7.3. New Projects Concepts:

7.3.1. Decentralised Compost Plant:

Since there were land issues and other problems associated with Centralised Compost Plant Projects, OUIDF developed a Model for implementation of Decentralised Waste Processing Facilities across ULBs with a Pilot Project at Bhubaneswar.

To develop this model, OUIDF -

- Conducted Workshops with Vendors
- ► Visited Decentralised Plants in various locations in the Country
- Developed transaction structure that incentivized greater participation of Bidders
- ▶ Engaged with the industry players in SWM field and developed a large network of interested Bidders
- ► Assisted in Bid Process Management for Pilot Project at Bhubaneswar

7.3.2. Toilet on Wheels:

To raise awareness about sanitation and to raise the service level standards with respect to Public Toilets in Odisha, the "Toilet on Wheels" Project was conceived for Bhubaneswar, based on "Ti Toilets" theme in Pune City. In this regard OUIDF undertook the following activities:

- ► Engaged with Vendors and BMC to fine tune the design
- ▶ Developed transaction structure and bid documents. Engaged with the industry players in sanitation and developed a large network of interested Bidders
- Assisted in Bid Process Management for Pilot Project at Bhubaneswar

7.4. Field Visits

Field Visits were undertaken to ULBs located across the State of Odisha to identify opportunities for infrastructure development especially in the sectors like Solid Waste Management and Water Body Reclamation and Renovation and Commercial Market Complexes etc.

OUIDF and PDA Officials also undertook a site visit to an operational Abattoir in Visakhapatnam to understand the functioning and operational aspects of a Modern Abattoir in light of the requirement of selection of Operator for the Modern Abattoir set up in Gadakana by Bhubaneswar Municipal Corporation under OUIDF funding.

7.5. Grounding of Projects

During this period the Water Supply Project at Gopalpur was commissioned. Impact Evaluation Study of the Project has been undertaken by OUIDF and shared with the Government. Besides this, the Projects like Modern Abattoir at Gadakana, Wet Markets at Ghatikia and Unit-IV, Fish Markets at Sambalpur have either been completed or are near completion.

7.6. Training and Workshop

OUIDF held Workshops at BMC and SMC for Project Monitoring and also developed formats for reporting and tracking Progress of Projects.

Further, OUIDF also organized One-Day Workshop on Project and Contracts Management in collaboration with NICMAR, Pune which was attended by over 90 Officials and Engineers from ULBs, Development Authorities, OWSSB, PHEO and other PMUs under HUDD. It was first of its kind in the State.

This will go a long way in accelerating the pace of Project Development and also effectuate Project Implementation within budgeted costs and time for Projects being financed by KfW under both the Ist and the 2nd Lines of Credit.

Review Meetings

During the Financial Year 2017-18, Review Meetings were held at the level of Commissioner-cum-Secretary, H&UD Dept. to review the Progress of Projects sanctioned by OUIDF in the presence of all the stakeholders in order to improve the Project Monitoring Mechanism and Execution of Projects within Budgeted Costs and Approved Timeline.

Apart from the review by the Commissioner-cum-Secretary, H&UD Dept. and Secretary, OUIDF & Ex-Officio, Special Secretary, H&UDD, on the 4th Friday of every month regular Meetings are held with the Municipal Commissioner, Development Authorities and Urban Local Bodies to have first-hand information on the implementation of the Projects at the ground level. The Tender Status, Approval and Clearances of the Projects, Land Issues along with Billing and Payment Schedules are reviewed in details in the aforesaid Meetings.

The problems faced by the Executing Agencies vis-à-vis the Stakeholders are sorted out there at across the table. More so, Review of each Project is done through MS-Excel based Gantt Chart on fortnightly basis and Physical and Financial Progress are monitored. Remedial measures are undertaken for the Projects as necessary. The Minutes of Meeting is sent to all the Participants and followed up at regular intervals. Further, Project specific WhatsApp Groups have been formed to monitor the Projects on daily basis.

11.2. Visit of KfW Mission and Country Director, KfW on 19th December' 2017

The KfW Mission visited Odisha for signing of Agreement with Govt. of Odisha on 19th December' 2017 in presence of the Hon'ble Chief Minister of Odisha for the 2nd Line of KfW Assistance to OUIDF amounting Euro 55 Mn. And Technical Assistance of Euro 2 Mn.

11.3. KfW Mission Team Visit: 23rd to 26th February' 2018

The Mission had discussion with OUIDF and other Stakeholders regarding "Steps for Future Co-operation" and with Housing & Urban Development Deptt. as well as Sewerage Board on Sewerage Projects. Further, the Team also had Field Visits to have first hand feel of OUIDF assisted Projects. They visited the Bulk Water Supply Project, Ist of its kind in the Country and expressed satisfaction on the Project.

Atal Mission for Rejuvenation and Urban Transformation (AMRUT)

Atal Mission for Rejuvenation and Urban Transformation (AMRUT) Programme is a Centrally Sponsored Scheme launched by the Ministry of Urban Development (MoUD), Government of India on 25.06.2015. This Programme will be implemented over a period of 5 years i.e. from 2015-16 to 2019-20. So far Odisha is concerned, the following 9(nine) Cities / Towns having more than 1.00 lakh (one lakh) population are covered under AMRUT Scheme:

1.	Bhubaneswar Municipal Corporation	6.	Puri Municipality
2.	Cuttack Municipal Corporation	7.	Balasore Municipality
3.	Berhampur Municipal Corporation	8.	Bhadrak Municipality

AMRUT Mission Statement & Guidelines provide for creation of a Financial Intermediary in order to pool funds from all sources and release funds to ULBs on time. Such intermediary will also be able to access external sources of finance, such as debt and bonds, which small and financially distressed ULBS are unable to access. Accordingly, it has been decided that OUIDF will act as Financial Intermediary for implementation of AMRUT Scheme in Odisha in order to pool funds from all sources and release the same to the Executing Agencies / ULBs on time.

Hence, OUIDF as Financial Intermediary, is maintaining the AMRUT Account of the State Mission Director. The Executing Agencies are given Limits under PFMS Portal every month and have access to the Mission Director's Account as per the Allocated Limit. All the Books of Accounts, Records, Vouchers, Utilisation Certificates etc. are maintained at OUIDF Office. As of now 152 Nos. of AMRUT Projects have been implemented in the State which are in various stages, with a total disbursement of Rs. 321Crs. up to 31st March' 2018.

Incidentally, Odisha has bagged third / second position in the Country consecutively for the third year since inception.

3.2. Fish Market at 2 locations in Sambalpur

The Board approved Revalidation of the Original Sanction dated 13.04.15 up to 30.06.18 for the purpose of construction of ETP at both the Fish Markets.

3.3. Modern Abattoir at Gadakana by BMC

The Board approved Revalidation of the Original Sanction dated 28.04.14 and the Additional Sanction dated 17.11.16 and extended validity of the Sanction up to 31.12.17.

3.4. Bulk Water Supply to IIT, NISER, Infocity II, Jatni, Khurda on PPP

The Board approved ratification of the Original Sanction Order dated 13.04.15 which was Revalidated by the Chief Secretary, Odisha & Chairperson, OUIDF on 30.05.17 up to 31.03.18. IDCO may be advised to present the status of tie-up of industries/ clients for off-take of water from the committed quantity by IDCO.

3.5. Sewerage System at Rourkela East & West

The Board approved ratification of the prepayment of Rs. 100 crore (Loan & Grant of Rs. 50 Crore each) made by OWSSB from the Funds availed by them for the Sewerage Projects at Rourkela East and West.

3.6. EWS Housing Projects at 3 locations viz. Subhudipur, Satyanagar and Gadakana by Bhubaneswar Development Authority
