PREFACE

I am glad to know that Odisha Urban Infrastructure Development Fund (OUIDF) functioning under Housing & Urban Development Department is bringing out its 5^{th} Annual Report for the year 2016-17.

Urbanisation is a clear indicator of development and in the past decade, Odisha's urban population has swelled to about 18% of the total population of the State. It is expected to grow at a still faster rate in the coming years with upcoming industrial parks, manufacturing hubs, growth clusters and unabated urban migration. The rapid pace of urbanization is fraught with new challenges of providing infrastructure and basic urban services at affordable costs to different sections of the population. This calls for intensive capital investments which ULBs themselves are not able to arrange from their own resources within a limited period of time.

Realising this need, the State Govt has constituted the OUIDF for financing eco-friendly urban infrastructure projects. The objective is to recoup the loan through increasing revenue that the ULBs are expected to generate from such projects. Till FY 2016-17, OUIDF has sanctioned loans and grants of around Rs.645 cr against 24 projects in various ULBs. These funds need to be utilized judiciously to make cities 'livable' and 'lovable'.

I hope the publication of the Annual Report will provide a scope for self assessment and identification of the gaps in meeting the social infrastructure needs of ULBs, Development Authorities and Statutory Bodies of Odisha. I compliment the Trust and its Team for preparing this Annual Report and wish the publication all success.

1. Background

Infrastructure Development is a vital necessity, being the prime mover of economic progress across all sectors of the economy contributing to inclusive growth thereby benefiting people in reducing Poverty and improving their Quality of Life.

Urbanisation is the process of economic, spatial, and social transformation over a period of time involving people from all strata of the society. With the growth in urban population and the pressure of its inhabitants on Urban Infrastructure, there is an increasing need for a holistic development of urban facilities through proper planning for Projects, time-bound execution and delivery of quality service at affordable costs. Sustainable Urban Infrastructure Development is therefore a critical need & more so in the sub-sectors like potable Drinking Water, Sanitation and Sewerage, Solid Waste Management, Slum Rehabilitation and Affordable Housing for the Economically Weaker Sections. Coupled with the enormous positive externalities these Projects assume a significant role for the accelerated Economic Development of the Country.

I.I Structured Framework for Urban Infrastructure Development -A Need in Odisha:

According to Census 2011, Odisha continues to be among the least urbanized States in India with an urban share of population of about 17%. However, the pace of urbanization in Odisha continues to intensify due to rapid industrialization and good economic performance, which has led to impressive growth in several areas as reflected below:

- a. Urban population grew at 26.8% during 2001-11 which is double the National Growth vis-à-vis Rural Population Growth of 11.7% during the same period.
- b. The number of towns increased from 138 in 2001 to 223 in 2011 (largely due to increase in Census Towns from 31 to 116, even though Statutory Towns increased from 107 to 112).
- c. Budgetary outlay of Housing & Urban Development Department (HUDD) has increased at a Compounded Annual Growth Rate (CAGR) of 19% during the period 2006-07 to 2016-17.

Odisha has 112 Urban Local Bodies (ULBs) across three categories, namely, 5 Municipal Corporations, 45 Municipalities and 62 Notified Area Councils (NACs). The legal framework for the urban sector is provided by the Odisha Municipal Corporations Act, 2003 (that applies to Five Municipal Corporations) and the Odisha Municipal Act, 1950 (that applies to the Municipalities and the NACs).

The last decade has witnessed a steep growth in urban population. Rapid urbanization has posed huge challenges and created Opportunities for Infrastructure Development, Housing, Slum Development, Water Supply, Sanitation, Transport, Environment and Livelihood for the Urban Poor. Keeping in view the rapid urbanisation process in Odisha, the State Government has been putting maximum emphasis on planned growth of its cities/ towns with adequate infrastructure and basic amenities. This is provided through the Urban Local Bodies and Parastatal Agencies. Further concrete measures are initiated for efficient management and delivery of civic services like provision of Affordable Housing, Safe Drinking Water, Sanitation including Solid Waste Management, Storm Water Drainage, Roads and Public Transport while creating Livelihood Opportunities by accelerating Economic Growth of Cities, Towns and Building Capacity of the Urban Poor.

However, "Municipal Finances" are weak. Capital investments continue to rely on Govt. of Odisha (GoO)'s Budgetary outlays and grants. Debt financing is limited to State supported Projects and constrained by inadequate capacity to develop bankable Projects.

Finances of ULBs continue to be stressed leaving little surplus for investment. Urban Local Bodies face severe constraints - both financial and organizational to be able to-

- > Put in place processes for planning and delivering their functions,
- Identify / implement Projects to improve service delivery, and
- Manage / improve their finances.

Even though the Municipal legal framework allows flexibility to access loans at the ULB level, debt financing of urban projects is almost non-existent. Dedicated Urban Infrastructure Fund such as Odisha Urban Infractructure Development Fund has provided a platform for the ULBs to access funding for Eco-friendly Urban Infrastructure Projects e.g., Waterbodies, Abattoirs, Wet Markets etc. These Environmental Friendly Projects go a long way in changing the Urban landscape of the ULBs.

Envisaged Benefits:

- Integrated approach to Urban Development: access to fixed, low interest long-term funds and technical assistance to build expertise in implementing 'bankable' projects.
- Combination of Government oversight and professional efficiency.
- Scalability: Allows managing multiple funds and leveraging of other funds.
- ▶ Introducing ULBs to rigor of debt servicing discipline.
- Facilitating access of ULBs to external finance and capital markets.
- Greater scope for private sector participation in asset creation and service delivery.

2. Odisha Urban Infrastructure Development Fund

2.1. Vision & Mission

Vision

The Vision of OUIDF is to be a sustainable financial intermediary that enhances the flow of private capital to urban sector in Odisha and facilitate Urban Local Bodies to become capable and sustainable organisations, sensitive to stakeholders in providing the highest quality of Urban Services.

Mission

The Mission of OUIDF is to contribute to improvement in urban quality of life in Odisha by facilitating efficient Urban Infrastructure Asset Creation and Provision of Urban Service through Innovative & self sustainable Projects.

2.2. Objective of Odisha Urban Infrastructure Development Fund (OUIDF)

Government of Odisha, with assistance from KfW, Germany has set up the Odisha Urban Infrastructure Development Fund (OUIDF) for the purpose of Developing and Financing Eco-Friendly Infrastructure Projects undertaken by Urban Local Bodies, Statutory Bodies, Public Sector Undertakings and Private Investors and attracts Inter alia, investment, professional advice from Institutions for financing Infrastructure Projects.

The primary objective of creating OUIDF is to progressively increase external financing of ULB level capital projects in a sustainable manner, without a "State Government Guarantee." Creation of OUIDF, as part of an over-arching Urban Development Programme, would enable this through:

- a. Catalyzing development of well-structured bankable projects
- b. Building capacity in Project Appraisals and Resource Mobilization and
- c. Facilitating/ sensitizing State and ULB level reforms that can be pre-cursors for further investment flows.

OUIDF's charter contains the following focus areas and objectives:

a. To provide financial assistance to Urban Local Bodies, Statutory Boards, Public Sector Undertakings and Private Investors, for setting up positive environment impact Infrastructure Projects in the State of Odisha.

- b. To provide loans or take equity position in the Infrastructure Projects sponsored by Private Investors on a commercial basis when the Infrastructure Projects are considered strategically important.
- c. To become financially self sustainable and to mobilize sources (including private and capital market) to finance Urban Infrastructure Development.
- d. To only invest in Infrastructure Projects that at the time of the investment comply with all relevant State and Central Government legislation regarding environmental and social protection.

Sector Focus:

Sectors and Projects with positive environment and social impacts:

- ▶ Water Supply and Water Supply Improvement Schemes (WSIS);
- Underground Sewerage Schemes (UGSS);
- Solid Waste Management (including landfill sites, waste-to-energy, segregation, recycling and reuse, larger compost yards / dump area);
- Climate Adaptation Measures (e.g. Storm Water and Flood Drains);
- Slum Development, Rehabilitation, Provision of Basic Amenities to Informal Settlements.

The OUIDF, has been set up as a Trust (under the Indian Trust Act, 1882) under H&UD Deptt. having a Board of Trustees, which will define the "Funds' Charter and Disbursement Guidelines." The Chairperson and the Members of the Board of Trustees have been nominated by GoO. The Trust came in to existence vide Govt. Notification No. 2709, date: 31.01.2012 and Registered Trust Deed dated: 20.03.2013. The Board of Trustee are as under:


The above Trustees shall be collectively known as "Board of Trustees" who would manage and administer the affairs of the Trust and Trust Board.

2.3. Institutional Framework of OUIDF

2.3.1. The Institutional Framework of OUIDF consists of an Urban Loan Fund (the "Loan Fund"), a Grant Fund (the "Grant Fund") and Project Development Fund (the "PDF"). A Project Development Agency will be set up to manage the Funds. The Project Development Agency (PDA) would be responsible for development, appraisal, financing and monitoring of Urban Infrastructure Projects in Odisha. The PDA would manage three Funds under the OUIDF Trust as described below:

- i) Urban Loan Fund (ULF): An Urban Loan Fund (ULF) has been set up to provide loans to urban projects on a non-guaranteed mode. GoO will bring in equity contribution equivalent to 5 Million Euro into the ULF.A Line of Credit equivalent to 25 Million Euro will be made available by GoO to ULF for on-lending to Urban Projects. The PDA would have responsibility for identification, development, appraisal, sanction, disbursement and repayment of loans under the ULF, in accordance with the guidelines developed and approved by the Board of Trustees of OUIDF.
- ii) Grant Support Fund (GSF): The GSF would be created to provide Capital Grants to implementing agencies to bridge viability gaps in urban sector projects and to complement debt financing from ULF. The GSF will have an initial corpus equivalent to 25 million Euro. The above allocation of the Line of Credit equally between the ULF and GSF is only the initial allocation. However, if the PDA is able to develop projects with lower viability gap funding requirement than the limit of 50% proposed, the remaining amounts in the GSF will be transferred for loan funding from the ULF.
- iii) Project Development Fund (PDF): The PDF would be available to finance Project Preparation and Development of Bankable Projects based on the guidelines for access to the PDF developed by the PDA initially and approved by the Board of Trustees. While the focus of the PDF will be to finance preparation of Detailed Project Reports (DPRs), it would also be used to undertake other project preparation activities (including preparation of City Development Plans, Pre-Feasibility Studies and Feasibility Studies) that eventually lead to preparation of bankable projects. The PDA and its Associates will not be allowed to participate in downstream project development activities undertaken with funding from PDF.

3. Support from Government of Germany through Kf W


3.1. Support from Government of Germany through KfW

On the basis of the Agreement dated: 15.05.2009 between Govt. of Fedral Republic of Germany and Govt. of India on Financial Cooperation (Govt. Agreement) the Borrower and KfW have entered into agreement for grant of Euro 50 Million as Loan Fund and Euro 2.5 Million as Technical Assistance. The detailed conditions are as under:

- Reduced interest loan of Euro 50 million (INR 400 Crore approx.) and technical assistance grant of Euro 2.5 million (INR 20 Crore approx.) form KfW at a fixed interest rate with a tenor of 15 years including 5 year principal moratorium.
- Government of India shall channel the loan through GoO to OUIDF. GoO to pass 50% of the funds (i.e. Euro 25 million) as a Capital Grant to ULBs through Grant Support Fund of OUIDF and remaining 50% as Loan through the Urban Loan Fund of OUIDF. Technical assistance grant will be passed to the Project Development Fund of OUIDF.
- The Borrower will repay the loan to KfW in 21 consecutive semi-annual instalments of Euro 2,381,000.00 starting from 31.12.2017 with interest @ 1.875% per annum.
- The currency risk will be borne by the Project Executing Agency. Balance 50% of the fund (Euro 25 million) shall be passed on as capital grant to Grant Fund of the Project Executing Agency. The Project Development Fund of Euro 2.5 million for technical assistance shall be transferred as a grant to the Project Executing Agency. The OUIDF has been structured to absorb/ accept further bilateral/ multilateral agencies' investment in future.

3.3. KfW Line of Credit

Status of Utilisation

OUIDF has availed a Line of Credit amounting to 50 Million Euro (Approximately Rs. 400 Crores) for financing Urban Infrastructure Projects in Odisha. The Project is envisaged for a period of four years from 2012-13 to 2015-16. The disbursement schedule of KfW is given below:

4. Activities of OUIDF

As per Clause no. 1.1 of the Separate Agreement executed between KfW, Germany and Government of Odisha on 2nd August 2012, the Project Development Agency (PDA) has been appointed on 5th August 2014 through a competitive bidding process for providing technical support to OUIDF in project development, to undertake project appraisal through innovative structuring of bankable projects, to facilitate sustainable urban infrastructure financing and to mobilize external funds for promoting Urban Infrastructure Projects in the State of Odisha.

4.1. Various activities undertaken by OUIDF during the Year 2016-17:

- I. Appraisal of Projects for Financial Assistance: Nine projects in various sectors such as Street Lighting, Affordable Housing for EWS and Solid Waste Management Projects were appraised and approved by the Board of Trustees of OUIDF.
- 2. Project Development Activities for SWM Projects: OUIDF has undertaken monitoring of the DPR preparation activities of the SWM Consultants appointed by OUIDF, Assistance in identification of land and representation to SEIAA and MoEF for obtaining Terms of Reference for EIA studies.
- 3. Standard Operating Procedure: Standard Operating Procedure for Management and Maintenance of Hygienic Wet Markets, Management and Maintenance of Water Bodies and Allotment of Shop Units by ULBs have been prepared to enable ULBs to adopt best practices in O&M for Projects and adopt transparent process for Allocation of Shops.
- 4. Support in Bid Process Management: OUIDF has been providing handholding support in preparation of Tender Documents, follow up with Prospective Bidders and Evaluation of Bids received for some of the projects funded by OUIDF.
- 5. **Project Monitoring:** The Physical and Financial Progress of Projects are closely monitored by OUIDF using Project Management Tools such as MS Project and Gantt Chart using MS Excel.
- 6. Assistance to H&UD Deptt. regarding National Green Tribunal: OUIDF provided assistance in preparation of responses to National Green Tribunal directives w.r.t "Implementation of Solid Waste Management in Odisha" from time to time.
- 7. Identification of Innovative Projects: Innovative Projects were identified that can be implemented in various ULBs in the State, e.g. One such Project is "Toilet on Wheels" where buses not in use are refurbished and converted into modern, clean toilets aimed at catering to sanitation needs in slums and market places. The Pilot Project shall be implemented in Bhubaneswar.

6. New Projects – Approved

The details of the Projects sanctioned by the Board of Trustees of OUIDF during the Financial Year 2016-17 are as follows:

6.1. Energy Efficient LED Street Lighting Projects at Bhubaneswar, Cuttack, Berhampur, Sambalpur & Rourkela.

Energy Efficient LED Street Lighting Projects envisage introducing the technical interventions covering Installation of Street Lighting System, both Greenfield and Retrofitting, Improvement Plan Preparation, Infrastructure upgrading and LED Luminiare Retrofitting over a Project Implementation Period of I year. Use of efficient lighting infrastructure could help reduce the energy usage of the Municipal Corporations between 25-60%. In addition, the operational optimisation such as use of twilight switching controls, dimming and voltage optimization, could lead to an additional energy savings of 15-20%. These Projects shall be taken up for implementation by 5 Municipal Corporations in Odisha, namely, Bhubaneswar, Cuttack, Berhampur, Sambalpur and Rourkela and shall be executed by a Special Purpose Vehicle (SPV) formed by M/s Odisha Project IVS (a 100% owned subsidiary of M/s Novalume A/S of Denmark) and its Indian Consortium Partner, M/s Neev Energy LLP together with M/s Energy Efficiency Services Ltd., a Joint Venture Company of PSUs of Ministry of Power, Govt. of India, in accordance with the Supply Installation Operation and Maintenance (SIOM) Agreement. The Project SPV shall carry out O&M activities and undertake periodic repairs and maintenance of the Street Lighting Systems as required for 7 years from the date of commissioning. The Project would lead to energy reduction and reduced load on the grid with substantial reduction to greenhouse gas emission resulting from the energy saving.

The Board of Trustees of OUIDF in its 9thMeeting held on 19th August, 2016 sanctioned Loan and Grant for the respective Projects as elaborated below:

i. Energy Efficient Street Lighting Project (Phase - II) at Bhubaneswar by Bhubaneswar Municipal Corporation (BMC)

BMC has an estimated 35,000 Street Lighting Fixtures under its jurisdiction of which 19,873 Energy Efficient LED Street Lighting Systems were installed in Phase I under a separate Project. The proposed Project envisages setting up of 6,136 Energy Efficient Street Lights in Bhubaneswar covering the areas not considered under Phase I and some new stretches. The total Project Cost is Rs. 481.44 Lakh. The Project shall be funded by OUIDF through the Sanctioned Loan & Grant of Rs. 193.40 Lakh each, while BMC shall bring in its contribution of Rs. 48.14 Lakh and the SPV shall contribute the balance amount of Rs. 46.50 Lakh.

ii. Energy Efficient Street Lighting Project at Cuttack by Cuttack Municipal Corporation (CMC)

The total number of Street Lights under the CMC is 17,852 usually Sodium Vapour Lamps and Tube Lights. The Project envisages installation of 16,069 Energy Efficient LED Street Lights in Cuttack that would cut down the energy costs of the Municipal Corporation significantly. The Total Project Cost is Rs. 1082.98 Lakh. The Project shall be funded by OUIDF through the Sanctioned Loan & Grant of Rs. 435.04 Lakh each while CMC shall bring in its contribution of Rs. 108.30 lakh and the SPV shall contribute the balance amount of Rs. 104.60 Lakh.

iii. Energy Efficient Street Lighting Project at Berhampur by Berhampur Municipal Corporation (BeMC)

There are 8,423 street lights under BeMC comprising both Tube Lights & Sodium Vapour Lamps. The Project envisages installation of 7,578 Energy Efficient LED Street Lights in Berhampur that would significantly reduce the energy costs of BeMC. The Total Project Cost is Rs. 571.51 Lakh. The Project shall be funded by OUIDF through the sanctioned Loan & Grant of Rs. 229.58 Lakh each while BeMC shall bring in its contribution of Rs. 57.15 Lakh and the SPV shall contribute the balance amount of Rs. 55.20 Lakh.

iv. Energy Efficient Street Lighting Project at Sambalpur by Sambalpur Municipal Corporation (SMC)

SMC operates and maintains 5,418 street lights with both Sodium Vapour Lamps & Tube Lights. The Project envisages installation of 4,869 Energy Efficient LED Street Lights in Sambalpur that would significantly reduce the energy costs of SMC. The Total Project Cost is Rs. 360.30 Lakh. The Project shall be funded by OUIDF through the sanctioned Loan & Grant of Rs. 144.74 Lakh each while SMC shall bring in its contribution of Rs. 36.03 Lakh and the SPV shall contribute the balance amount of Rs. 34.80 Lakh.

v. Energy Efficient Street Lighting Project at Rourkela by Rourkela Municipal Corporation (RMC)

There are 7,237 Street Lights under RMC comprising both Sodium Vapour Lamps & Tube Lights. The Project envisages installation of 6,494 Energy Efficient LED Street Lights in Rourkela that would significantly reduce the energy costs of RMC. The Total Project Cost is Rs. 511.46 Lakh. The Project shall be funded by OUIDF through the Sanctioned Loan & Grant of Rs. 205.46 Lakh each while RMC shall bring in its contribution of Rs. 51.15 Lakh and the SPV shall contribute the balance amount of Rs. 49.40 Lakh.



6.2. Rehabilitation Project of Slums & Informal Settlements for Economically Weaker Sections by Bhubaneswar Development Authority (BDA) at Subudhipur, Satyanagar & Gadakana in Bhubaneswar

Rapid Urbanisation of Bhubaneswar has led to widespread migration of people from rural & semi-rural areas, leading to a surge in formation of slums due to lack of Affordable Housing. The 436 slums play host to 34% of the population of Bhubaneswar City. However the slums lack basic amenities like water supply, sewerage, sanitation, electricity etc.

The Government of Odisha through Housing & Urban Development Department is working towards achieving its vision of making Bhubaneswar a slum free city and has come up with initiatives in the form of Affordable Housing Projects to be undertaken at different places in and around the city under the new "Housing for All in Urban Areas, Odisha, 2015" Policy. Taking into account the inadequate housing stock for EWS in Bhubaneswar, BDA has come up with the proposed Projects to provide Affordable Housing for EWS in Bhubaneswar. Through this initiative, the poor slum dwellers in the city of Bhubaneswar will have access to basic amenities like water, electricity, sanitation, drainage etc. leading to better living conditions.

i. EWS Housing Project at Subudhipur, Bhubaneswar

The Project aims to construct 342 Dwelling Units on a plot area of 1.49 acre at Subudhipur. The individual Dwelling Unit has been designed with Carpet Area of 24.8 sq.m. and Built-up area of 34 sq. m. with basic amenities like water supply, sewerage and sanitation and shall be sold to the Beneficiaries at a price of Rs.. 1.50 Lakh per unit. The Total Project Cost is Rs. 2,122.24 lakh.

The Board of Trustees of OUIDF in its 10th Meeting held on 5th January 2017, sanctioned a Loan of Rs. 955 Lakh & Grant of Rs. 955 Lakh in favour of Bhubaneswar Development Authority.

ii. **EWS Housing Project at Satyanagar, Bhubaneswar**

The Project aims to construct 928 Dwelling Units on a plot area of 4.58 acre at Satyanagar. The individual Dwelling Unit has been designed with Carpet Area of 24.8 sq.m. and Built-up area of 34 sq. m. with basic amenities like water supply, sewerage and sanitation and shall be sold to the Beneficiaries at a price of Rs., 1.50 Lakh per unit. The Total Project Cost is Rs. 6,047.11 Lakh.

The Board of Trustees of OUIDF in its 10th Meeting held on 5th January 2017, sanctioned a Loan of Rs. 2,721.20 Lakh & Grant of Rs. 2,721.20 Lakh in favour of Bhubaneswar Development Authority.

iii. **EWS** Housing Project at Gadakana, Bhubaneswar

The Project aims to construct 1,392 Dwelling Units on a plot area of 6.364 acre at Gadakana. The individual Dwelling Unit has been designed with Carpet Area of 24.8 sq.m. and Built-up area of 34 sq. m. with basic



amenities like water supply, sewerage and sanitation and shall be sold to the Beneficiaries at a price of Rs. 1.50 Lakh per dwelling unit. The Total Project Cost is Rs. 8,661.01 Lakh.

The Board of Trustees of OUIDF in its 10th Meeting held on 5th January 2017, sanctioned a Loan of Rs. 3,897.45 Lakh & Grant of Rs. 3,897.45 Lakh in favour of Bhubaneswar Development Authority.

6.3. Solid Waste Management (SWM) Project at Berhampur by Berhampur Municipal Corporation (BeMC)

In Berhampur City, at present the Municipal Solid Waste (MSW) generated is around 140 MT per day and is disposed off without any treatment. This causes environmental hazards and also the possibility of pollution of the ground water. Hence, it is proposed to set up a processing facility and scientific disposal facility for management of the Solid Waste of Berhampur. BeMC plans to take up the Project on Design Build Operate and Transfer Mode and seek private sector participation for implementation and Operation and Management activities involved for SWM. The objectives of BeMC through this Project include establishment and operation of an efficient secondary collection and transportation system, processing facility to ensure segregation and treatment of waste, and scientific disposal of rejects to comply with the SWM Rules, 2016 on scientific treatment and disposal of solid waste.

The Total Project Cost is Rs. 3,874 Lakh and OUIDF shall provide a Loan of Rs. 1743 Lakh and a Grant of Rs. 1743 Lakh in favour of BeMC as sanctioned by its Board of Trustees in its 10th Meeting held on 5th January, 2017.

6.4. Sewerage System of Sambalpur Town

The Board of Trustees of OUIDF sanctioned a Grant of Rs. 4,000 Lakh in favour of Odisha Water supply & Sewerage Board (OWSSB) over and above the Loan of Rs. 4,000 Lakh pursuant to the deliberations and the decision taken in the Consultative Meeting under AMRUT Scheme held on 09.11.16. This was in light of the change in the technology and design of the STP and modifications to the core and non-core components of the Project.

8.3. Other Initiatives

A Study Tour was undertaken on 24th September, 2016 to Kolkata by the Officials of OUIDF and PDA along with Engineers of Berhampur Municipal Corporation to study the Static Waste Compactors, Solid Waste Management Treatment and Disposal Facilities in Kolkata. OUIDF provided support in preparation of Preliminary Project Proposals of Bhubaneswar Smart City for External Aided Funding and also in Preliminary Appraisal of Project Proposals by Asian Development Bank.

8.4. Meetings & Seminars

- (a) Odisha Urban Sanitation Strategy: A Meeting was held on 25th May 2016 in the Conference Hall of H&UD Department under the Chairmanship of the Commissioner-cum-Secretary, H&UDD to discuss the legislative framework and a presentation on Odisha Urban Sanitation Strategy by Centre for Policy Research.
- (b) Workshop on Urban Governance: A Workshop on Urban Governance was held on 29th August 2016, under the Chairmanship of the Honourable Chief Minister, with members from all the ULBs. The Special Secretary, H&UD Department gave a brief presentation about OUIDF and its activities.
- (c) Swachh Survekshan Seminar: The Workshop was convened on the behalf of Sri. Praveen Prakash, IAS, Joint Secretary and Mission Director, Swachh Bharat Mission on 22nd October 2016, at Bhubaneswar. The Seminar aimed at appraising the stakeholders about the Swachh Survekshan Mission and the parameters for the Survey to be carried out as part of the programme.
- (d) KfW Procurement Workshop: A Workshop was conducted on 17th November 2016 at Delhi by Ms. Rebecca, Procurement Expert, KfW regarding the Procurement procedures and guidelines to be followed relating to appointment of Consultants, Contractors etc. for the Projects funded by KfW. This Workshop was attended by Officials from CMWSSB, Koch Metro Water, NCRPB, TNUIFSL and OUIDF. Video Conference was also organised with the Project Managers and Procurement Team in KfW to sort out outstanding issues on Procurement.
- (e) District Level Meeting for SWM: In toto, 13 District Level Meetings were held for approval of Prefeasibility Report for SWM Projects initiated in various ULBs in the respective Districts. The Meetings were chaired by the District Collector/ ADM/ PDDRDA of the respective Districts. The land issues relating to SWM sites and the action plan for implementation were discussed in the Meetings.

9. Review Meetings

The Tender Status, Approval and Clearances of the Projects, Land Issues along with Billing and Payment Schedules are reviewed in details in the aforesaid meetings.

The problems faced by the Executing Agencies vis-à-vis the stakeholders are sorted out there at across the table. More so, Review of each Project is done through MS-Excel based Gantt Chart on fortnightly basis and physical and financial progress are monitored. Remedial measures are undertaken for the Projects as necessary. Further, Project specific WhatsApp Groups have been formed to monitor the Projects on daily basis.

The Delegation met with Commissioner-cum-Secretary, H&UD Department, Secretary, OUIDF and Ex-Officio Special Secretary, H&UD Department, and the Project Development Agency and held discussion regarding the following:
 - a. Utilization of TA Funds
 - b. Status of the Sub Projects
 - c. Monitoring of Implementation and Disbursements
 - d. Benchmarking of Financials of ULBs in Odisha vis-a-vis Tamil Nadu
 - e. Developments in Urban Infrastructure Financing in Odisha and Gol Initiatives.

The KfW Team undertook a site visit of the "Bulk Water Supply Project of IIT, NISER, Infocity II" at Munduli.

- 2. The Team discussed on the existing Projects, Smart City Projects in order to explore further key areas of cooperation.
- 3. December I to December 2, 2016: A Delegation of KfW Officials comprising Ms. Elke Peetz, Project Manager, Mr. Hilmar Rave, Sr. Engineer and Mr. Anirban Kundu, Deputy Director visited Bhubaneswar from December I to December 2,2016. The Delegation met the Secretary, OUIDF and Ex-Officio Special Secretary, H&UD Department, Vice Chairman, BDA and the Project Development Agency, and held discussions regarding the following:
 - a. Activities of OUIDF, Pipeline of Projects for Phase II
 - b. Procedure relating to Procurement and Procurement Guidelines

- c. Discussion on ECSMF of OUIDF and its Compliance with the Environmental Guidelines of KfW
- d. Project Monitoring by OUIDF

The KfW Team undertook a site visit of the Bulk Water Supply Project of IIT, NISER, Infocity II at Munduli and Modern Abattoir at Gadakana of BMC, Bhubaneswar.

4. March 6 to March 9, 2017: A Delegation of KfW Officials comprising Mr. Felix Klauda, Division Head, Ms. Elke Peetz, Project Manager and Mr. Anirban Kundu, Deputy Director visited Bhubaneswar from March 6 to March 9, 2017, to have discussions for the Appraisal Mission of Sustainable Urban Infrastructure Development Odisha, Phase-II. The Delegation held discussions relating to the Project Objective, Time Schedule of Fund Disbursement, the Roles and Responsibilities of OUIDF, Sanctioning Procedure etc. The Team also undertook a site visit of Water Bodies and Housing Projects for EWS category.

12.2. 21st May' 2016-Visit of German Federal Ministry for Economic Cooperation and Development (BMZ)

A Delegation from the German Federal Ministry for Economic Cooperation and Development (BMZ) visited Bhubaneswar along with Officials from GIZ and KfW, on May 21, 2016. The delegation met the Commissionercum Secretary, H&UD Department, Secretary, OUIDF and Ex-Officio Special Secretary, H&UD Department, Commissioner, BMC and CEO, BSCL.

The discussions revolved around the work done by OUIDF, Current status of Project Implementation, Issues faced by OUIDF, and Development of Smart City Projects in Bhubaneswar.

13. KfW 2nd Line of Credit

A Delegation of KfW Officials had visited Bhubaneswar from 6th to 9th March, 2017 and held discussions with Officials of OUIDF and H&UD Dept. as part of Appraisal Mission of Sustainable Urban Infrastructure Development, Odisha Phase 2. The key points of the discussion, *inter alia included* deliberations on the Objectives of the funding in 2nd Phase i.e., to strengthen OUIDF as a self-sustaining Organisation and an important instrument for ULBs and the Govt. to finance Municipal Infrastructure and help ULBs in providing quality and sustainable services to their citizens.

The Funds under the 2nd Line of Credit shall be fully sanctioned and disbursed within 6 years after signing of the Loan Agreement in accordance with the following schedule:

Further, the Total Cost of Projects to be financed was estimated at Euro 62.5 mn, with sources as detailed below:

(c)	Grant by KfW to OUIDF Project Development Fund	:	Euro 2 mn

The Loan from KfW shall have maturity up to 15 years with grace period of 5 years as in Phase 1 / 1st Line of Credit. Interest rate may be either fixed or floating as preferred by OUIDF & Govt.

H&UD Dept. had submitted to MoUD, Gol the Preliminary Project Report (PPR) along with requisite confirmation / self-certification of GoO from Debt Sustainability angle vide its Letter no. 14820/HUD dtd 30.06.17 as directed by DEA, MoF, Gol vide its Letter dated 20.03.17.

KfW has meanwhile submitted to OUIDF the Draft Loan, Financing, Project and Separate Agreements. The said Draft Agreements have been reviewed by OUIDF in light of the deliberations during visit of KfW Mission in March'17 and also from 31st Jul to 4th Aug, 2017. The Agreements have been examined by H&UD Dept. and submitted to Finance Department for concurrence.

14. Atal Mission for Rejuvenation and Urban Transformation (AMRUT)

Atal Mission for Rejuvenation and Urban Transformation (AMRUT) Programme is a Centrally Sponsored Scheme launched by the Ministry of Urban Development (MoUD), Govt. of India on 25.06.2015. This programme will be implemented over a period of 5 years i.e. from 2015-16 to 2019-20. So far Odisha is concerned, the following 9 (nine) Cities/Towns having more than 1.00 lakh (one lakh) population are covered under AMRUT Scheme:

- i. Bhubaneswar Municipal Corporation
- ii. Cuttack Municipal Corporation
- iii. Berhampur Municipal Corporation
- iv. Sambalpur Municipal Corporation
- v. Rourkela Municipal Corporation
- vi. Puri Municipality
- vii. Balasore Municipality
- viii. Bhadrak Municipality
- ix. Baripada Municipality

AMRUT Mission Statement & Guidelines provide for creation of a Financial Intermediary in order to pool funds from all sources and release funds to ULBs in time. Such intermediaries will also be able to access external sources of finance, such as debt and bonds, which small and financially distressed ULBS are unable to access. Accordingly, it has been decided that OUIDF will act as Financial Intermediary for implementation of AMRUT Scheme in Odisha in order to pool funds from all sources and release the same to the Executing Agencies/ ULBs in time.

Hence, OUIDF is maintaining a separate Bank Account of the State Mission Director, AMRUT in State Bank of India for Management of Funds under AMRUT Scheme. Further, Executing Agency / ULB-wise separate Accounts are maintained in the Nationalized Banks for Management of AMRUT Funds. All the payments from OUIDF to Executing Agencies and from Executing Agencies to the Vendors or vice versa are being operated through the Bank Accounts under PFMS portal only. In view of the aforesaid guidelines, OUIDF being the Financial Intermediary for AMRUT Funds is maintaining the relevant Records, Books of Accounts for the purpose.
