## OFFICE MEMORANDUM

In consideration of the online application ID: 275270 received on 26.05.2015 for າອbtaining Consent to Establish (NOC) of M/s Berhampur Waste Management Co. Pvt. Ltd. over plot nos. 1980, 1981, 1982 and 1982/2110 under respective khata nos. 669 and 563/606 in an area of ac. 33.237 dec. of Mouza - Mohuda under Tahasil - Kukudakhandi in the district of Ganjam, a unit not coming under 17 categories of highly polluting industries, the Regional Officer of State Pollution Control Board, Orissa, Berhampur conveys grant of consent to establish u/s 25/ 26 of Water (Prevention & Control of Pollution) Act, 1974 and u/s 21 of Air (Prevention & Control of Pollution) Act. 1981 and the rules framed there under for processing municipal solid wastes of Berhampur Municipal Corporation of quantity - 150 MT per day subject to the following conditions.

## GENERAL CONDITIONS

- This consent to establish is valid for the product, quantity, manufacturing process and 01. raw materials as mentioned in the application and for a period of 5 (five) years from the date of issue of this letter, provided commencement of production of the proposed project has not yet taken place in the mean time.
- 02. If the proponent fails to start operation of the project, but substantial physical progress has been made then a renewal of this consent shall be sought by the proponent.
- 03. If the proponent fails to initiate construction of the project and no significant physical progress is made then, the proponent has to apply for consent to establish afresh after expiry of 5 (five) years from the date of issue of this order.
- Adequate effluent treatment facilities are to be provided such that the quality of 04. sewage and trade effluent satisfies the standards as prescribed under E.P. Rule. 1986 or as prescribed by the Central Pollution Control Board, New Delhi and or State

Pollution Control Board, Odisha or otherwise as stipulated in the special conditions with amendment made thereof from time to time.

- All emission from the industry as well as the ambient air quality and noise are to conform to the standards as laid down under E.P. Rule, 1986 / Central Pollution Control Board, New Delhi / State Pollution Control Board, Odisha or otherwise stipulated in the special conditions.
- Of Adequate method of disposal of solid waste is to be adopted to avoid environmental pollution in the surrounding area.
- The industry is to comply to the provisions of Environment (Protection) Act, 1986, rules framed there and amendments made thereof such as the Hazardous Wastes (Management, Handling and Trans-boundary Movement) Rules, 2008, Manufacture, Storage and Import of Hazardous Chemical Rules, 1989 etc., The industry shall comply with the provisions of Public Liability Insurance Act, 1991, if applicable.
- The industry is to apply for grant of consent to operate u/s 25/26 of Water (Prevention & Control Pollution) Act, 1974 and 21 of Air (Prevention & Control of Pollution) Act, 1981 for a period of 5 (five) years at a time with requisite amount of consent to operate fee at least 3 (three) months prior to the commercial/ trial production and obtain consent to operate from the Board.
- 09. The industry is to take up the plantation of indigenous species around the available vacant areas inside the factory premises.
- 10. This consent to establish is granted subject to other statutory clearances to be obtained from Government of Odisha and/or Government of India as may be applicable thereof.

## SPECIAL CONDITIONS

- 1. Consent fees deposited are subject to total capital investment of rupees 40 crores only.
- The unit shall abide by the conditions stipulated in the environmental clearance dated 20.02.2015 of the project by SEIAA.
- The project is subject to the order of the Hon'ble High Court in W. P. (C) no. 13283/2014.
- Berhampur Municipal Corporation shall obtain authorization of the disposal site under the Municipal Solid Waste (M & H) Rules, 2000.

- 5 Permission of the Central Ground Water Authority shall be taken for consumption of ground water.
  - 6. Design of the landfill shall be submitted for approval.
- Under no circumstances, the industry shall discharge any wastewater to outside the plant premises. Generated waste / wash water shall be treated and used for plantations in compliance of prescribed quality standards.
- 8. Domestic effluent shall be discharged to soak pit via septic tank constructed as per BIS specifications.
- 9. Monsoon runoff water shall be collected and used for process and plantations.
- 10. There shall not spillage of garbage during collection and transportation.
- 11. Transportation vehicles shall be properly covered and moved properly through villages on road.
- DG set shall be provided with acoustic enclosure and anti vibration pad; height of the stack attached to the DG set (H) shall be as per the formula, H = h + 0.2√KVA where h is the height of the roof of the building where DG set is installed and KVA is the capacity of the DG set.
- 13. Ambient air quality inside the premises shall be maintained so as to conform the National Ambient Air Quality Standards as prescribed under the Environment (Protection) Rule, 1986 and amendments made thereof.
- 14. Plastic waste shall be segregated, treated, shredded and disposed to authorized recyclers.
- 15. There shall not be any ordour problem in the locality due to disposal of garbage.
- 16. On site emergency plan be prepared and implemented.
- Massive plantations shall be done along the boundary and vacant area of the premises to develop greenness of the area.
- 18. The unit shall abide by provisions under the Plastic Waste (Management & Handling) Rules, 2011.
- 19. The unit shall abide by provisions of the Environment (Protection) Act, 1986. amendments made thereof and rules framed there under.

The Board may impose further conditions or modify the conditions as stipulated in this order during installation and / or at the time of obtaining consent to operate and may revoke this order incase the stipulated conditions are not implemented and / or information is found to have been suppressed / wrongly furnished in the application form.
