- The Project shall be completed as per schedule by 31st March 2017

#### Wet Markets at Ghatikia and Unit IV by BMC

 BMC shall ensure demolition of existing structures at Unit IV and start construction activities at Unit IV latest by 2<sup>nd</sup> January 2017

- OUIDF to provide handholding support to SMC for evaluation of bids received.

### Reclamation of Water Bodies at Berhampur

- Single bid has been received for combined tender for Ramalingeswar and Haradakhandi.
  BeMC shall immediately cancel the tender and re-tender the project.
- OUIDF to quickly float the RFP for appointment of Consultant for DPR preparation of Agula tank and Construction Supervision for all three Water Bodies.

## Augmentation of Water Supply to Gopalpur NAC

- Project work is slow. PHEO to expedite the work to meet the scheduled completion date of 31st March 2017
- Budgetary allocation for Equity Contribution and OUIDF Debt Servicing is yet to be provided. PHEO shall provide from its budget

### Water Supply Project at Berhampur

 Budgetary Allocation to PHEO in the Supplementary Budget for Debt Servicing not provided. Re-appropriation to be considered.
